- 4) Speaker represents that, to the best of Speaker's knowledge, the materials Speaker has submitted do not violate or infringe on any personal, real or intellectual property rights of others.
- 5) Speaker hereby gives a non-exclusive right to use and to license the use of Speaker's name, photograph, likeness and/or voice in connection with the Video Program and/or promotional faculty videos and the advertising, publicizing, exhibition, and/or other exploitation of the Video Program and related promotional materials. Speaker further acknowledges that Lawline may utilize the Video Program and its contents, for use with Lawline's future product offerings, including but not limited to artificial intelligence powered features, and Speaker grants Lawline all necessary rights to do so.
- 6) Speaker acknowledges that Lawline, at its sole discretion, may remove Speaker's programs without further notice to the Speaker.

- 9) Both parties acknowledge that all rights not expressly granted shall be reserved to the respective parties.
